## 6. MAPPA in Practice

Case Example – Offender with a history of severe Mental Health

**Background** – A Man with a history of sexual offences and severe Mental Health

**MAPPA Level** – Managed at Level 3 due to the complexity and risk.

**Agencies Involved** -Police, Probation, Mental Health Services and Social Services.

### Actions Taken:

- A hospital order was in place under the Mental Health Act.
- A Multi Agency discharge plan was developed before release.
- Supervision and treatment were co-ordinated post discharge.
- Emergency protocols were agreed upon in case of relapse.

## 5. Management Levels

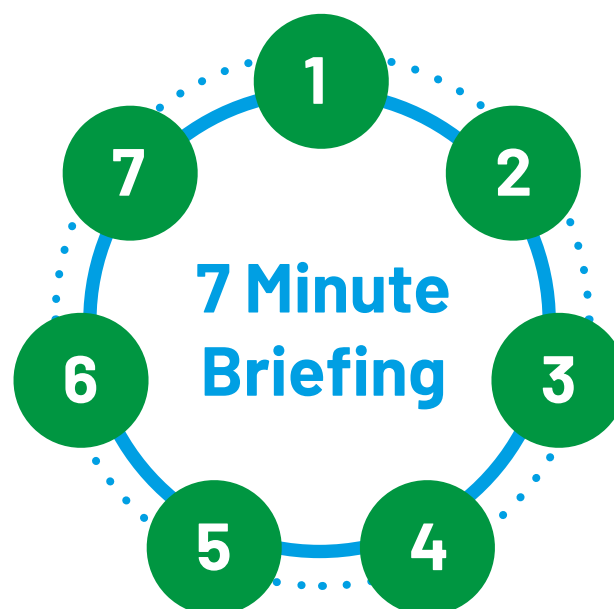
MAPPA uses 3 levels of management to determine how offenders are supervised based on the complexity of the case and the level of risk they pose to the public. The levels Apply across all MAPPA categories.

- **Level 1** – Single agency management (eg Police or Probation alone)
- **Level 2** – Active Multi Agency Management for Complex Cases
- **Level 3** – Senior oversight for the highest risk cases

## 1. What is MAPPA?

**Multi-Agency Public Protection Arrangements (MAPPA)** are statutory arrangements in the UK designed to manage the risks posed by certain sexual and violent offenders. They were established under **Sections 325 to 327 of the Criminal Justice Act 2003**.

MAPPA aims to protect the public by ensuring that agencies work together effectively to monitor and manage individuals who pose a risk of serious harm.



## 2. Key Features of MAPPA

### Purpose:

To assess and manage the risks posed by:

- Registered Sexual Offenders
- Violent offenders sentenced to 12 months or more
- Other dangerous individuals who pose a risk to the public

### Responsible Authorities

- Police
- Probation Service
- Prison Service

**Other agencies are legally required to support MAPPA**

## 3. MAPPA Meetings

Mappa meetings are structured multi agency discussions held to assess and managed the risks posed by offenders under the Multi Agency Public Protection Arrangements.

- To Share information
- To assess the risk an offender poses to the public
- To develop and review Risk Management Plans
- To coordinate actions among agencies to manage risks.
- To monitor compliance with conditions or restrictions.

## 4. Categories Of MAPPA

MAPPA classifies offenders into 4 categories to determine the level of risk they pose and the appropriate management strategy and level of multi-agency involvement.

**Category 1** – Registered Sex Offenders

**Category 2** - Violent and Other Sexual Offenders

**Category 3** - Other Dangerous offenders

**Category 4** - Terrorism or Terrorism related Offenders
